This service agreement may be term terminated by either party upon one-month prior written notice or with immediate effect in the event of the other party's insolvency or if the other party commits a material breach which is either not capable of remedy or which that party fails to remedy within 14 days of receipt written notice requesting the breach to be remedied.

While the shipment of goods it's a chance for loss and damage no one does that intentionally but due to various reason it happens sometimes that moment DpNEx Logistics compensate for the goods' mutual understanding as a condition of packing and invoice value.

Our service commitment

Rates quoted are based on DpNEx Logistic standard terms and conditions which are valid for services during the business hour of standard operation designated by us. Rates are calculated on the basis that shipment flows are from business address to business address.

Condition of customers responsible for themselves

- Unauthorized product inside packing.
- Every product name should be clearly mentioned inside the box.
- If their destination is in the Restriction area.
- Oversize, overweight, and remote charges customers must pay themselves.
- Address correction charge, customer should pay.
- *The Final Weight will be as per destination Counterpart customers must pay themselves.

Payment terms

The debtor and creditor agree to follow:

1. Balance. At the time of the agreement, the debtor owes the creditors amount of RS. 100000 for service as cargo and the courier charge. If the balance goes up more than that, the debtor should continue with a backdated cheque for the next transaction.
2. Payment instruction: The debtor is required to make payment within 7 days from the billed date.
3. Late payment: Any partial or late payment under this agreement is allowed in accordance with the following:
 - a. Allow the debtor to make payment within 15 days provided the debtor pays a late fee f: 2% charge of the total due amount every week ("extension period"). If payment is not made within the extension period, these agreements shall be in default.
 - b. If for any reason the debtor should not oblige to any section of a portion of this agreement, the debtor shall be considered in default. Under such an event the reaming balance of the amount owed shall be due within 7 business days with the debtor liable to pay all reasonable attorney's fees and cost of collection of the creditors. In addition, the creditors may reclaim any property or goods in connection with the amount owed, hold and dispose of the same, and collect expenses together with any deficiency due from the debtor, subject to the debtor's right to redeem said item pursuant to law.
 - c. This agreement shall be governed by and constructed in accordance with, the laws of Nepal. ("governing Law")

This agreement contains all the terms agreed to by the debtor and creditor relating to its subject matter including any attachments and addendums. This agreement replaces all previous discussions, understanding, and oral agreements.
